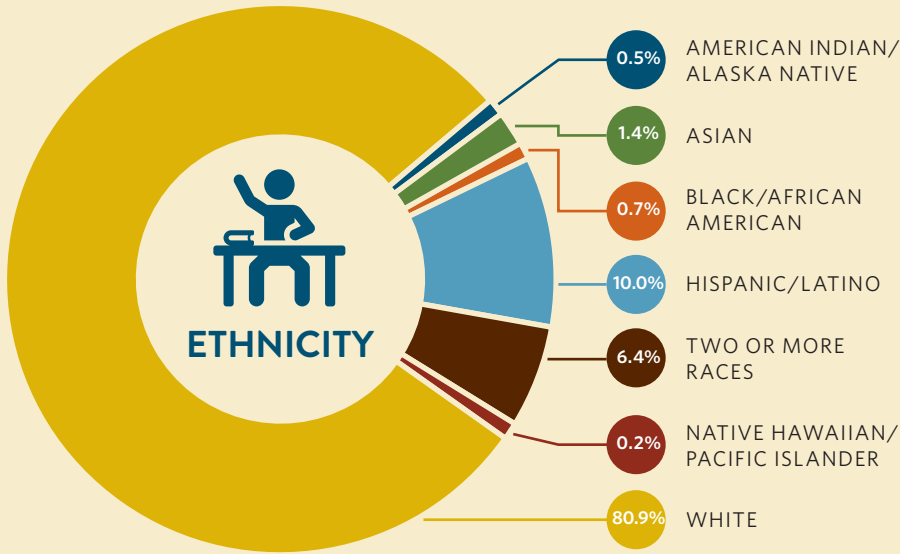

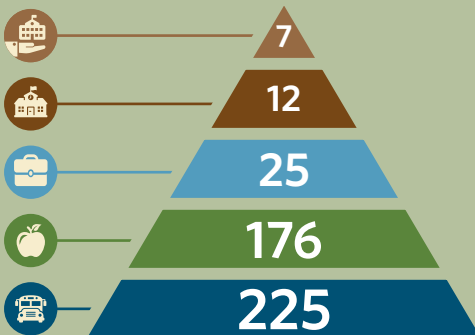

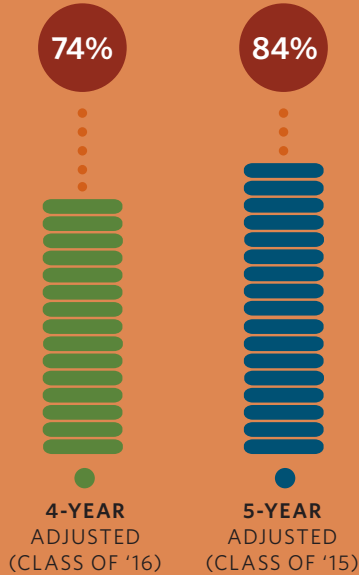

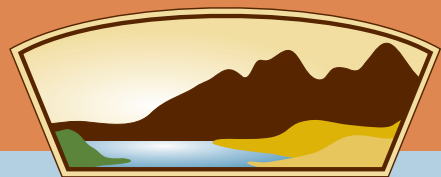

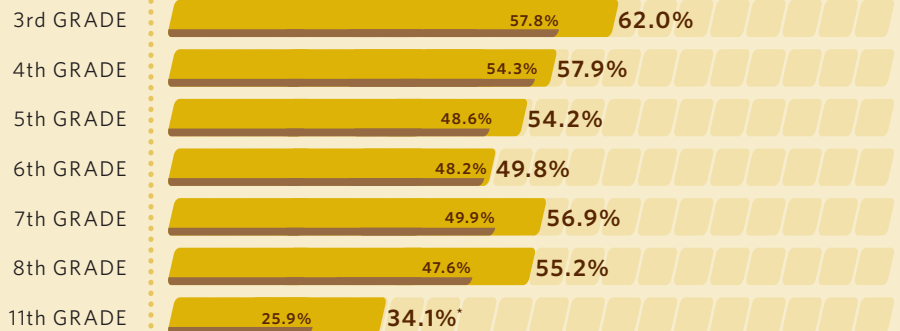

MATHEMATICS Smarter Balanced Assessment

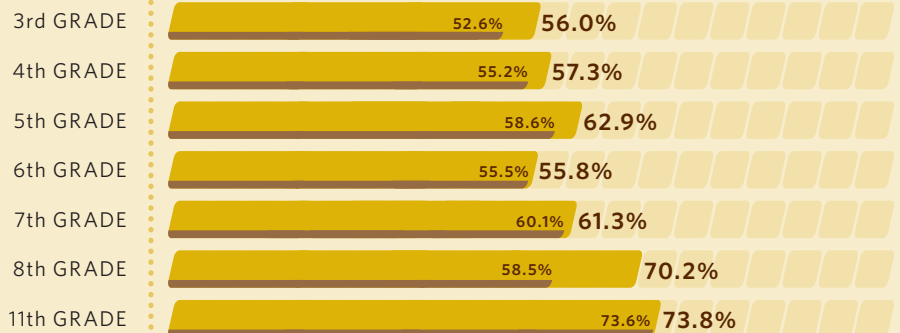
